Montana continues to support nearly all native species that were here historically present in the state. Sharp-tailed grouse are one of only a few native species missing from their original range in western Montana. They have deep cultural significance to native peoples and are a valued game species in eastern portions of the state.

Over the last 10 years, a genetic analysis, habitat evaluation, and restoration plan for sharp-tailed grouse in western Montana was completed and suggested that restoration was feasible. After evaluating this new information, FWP has developed four alternative strategies for restoring sharp-tailed grouse to western Montana and is seeking public comment to help guide our final decision.

The comment period extends for 30 days. Written comments will be accepted until 5:00 p.m. on March 17, 2019. The draft environmental assessment is available at the FWP office, 490 N. 





tice to quite a few scams that are very troubling. Saint Marie does have quite a few seniors and law enforcement agencies are warning citizens of these scams and frauds. Even the Valley County Dispatch received two scam calls this past week.

Many scams involve someone

ment agency, business or even a loved one in your family. These people try to convince you that they are a legitimate entity such as Medicare, the IRS or a loved one in trouble needing financial help. These scammers are good and very convincing to the point that many give personal information away to them such as bank account numbers, social security numbers, tax information, etc.

pretending to represent a govern-

Please do not fall for this.

Government agencies do NOT ask for personal information over the phone. These people will try to convince you sometimes that they are your grandchildren in trouble and need cash. If someone asks you "do you know who this is?" stay quiet or say NO. Make the caller tell you who they are. If you think it is one of your grandchildren and say their name, they are now establishing a fake identity. The scammer then will usually ask for money to solve

such as car repairs, a lost wallet, bail money etc. and usually will ask to have money sent via Western Union or MoneyGram. Don't be a victim and don't be embarrassed to tell someone if you have fallen for a scam. You may contact your local law enforcement agencies or Montana Department of Justice.
