# Montana Highway 200 Reconstruction Project Underway

Phase Two Of Project Between Jordan And Brockway Will Be Completed This Year

The Montana Department of Transportation (MDT) and Wickens Construction are back to work on phase two of the Montana Highway 200 (MT 200) reconstruction project. The project is comprised of five phases aimed at improving nearly 37 miles of MT 200 between Jordan and Brockway. Phase two is scheduled to be completed this year.

“We are excited to achieve another big milestone of this large-scale project,” said MDT Glendive District Administrator Shane Mintz. “MT 200 is an important route for residents, visitors, and commercial and agricultural vehicles. We are committed to completing the full project as safely and efficiently as possible.”

Phase two involves reconstructing more than nine miles of the highway, from 17 miles east of Jordan to just east of the Little Dry Creek Bridge, including constructing a new bridge over Little Dry Creek, which was completed in 2022. The grading and installation of gravel and cement-treated

base (CTB) on approximately seven miles of the project was also completed last year.

Crews have now returned to finish phase two, including reconstructing the remaining roughly two miles at the western end of the project area, paving, chip sealing (seal and cover), and finishing work on the entire project site. Phase two is expected to be completed in 2023; however, this schedule is subject to change due to weather and other unforeseen circumstances.

“As we enter our third year working on the project, the surrounding communities continue to be welcoming and supportive,” said President of Wickens Construction Casey Durbin. “We are grateful for their support and look forward to completing another phase of this vital project that will positively impact the region.”

When traveling through the project site, travelers can expect traffic reconfigurations, temporary signals, and reduced speeds. Short delays of up to 15 minutes may occur.

Phase three of the project, Flowing Wells East & West, spans almost seven miles east and west of the Flowing Wells Rest Area and is currently in the design phase. Construction is tentatively scheduled for 2025; however, this is subject to change due to construction schedules,

material availability, funding, and unforeseen circumstances.

Another MT 200 project scheduled for construction this year, separate from this larger MT 200 reconstruction project, is Circle Southwest. This project involves widening the shoulder, paving, and chip sealing from Brockway to Circle.

Improving Montana’s thousands of miles of state roads and highways is a vital component of Vision Zero. Vision Zero is an ongoing statewide collaboration among hundreds of agencies and organizations striving to zero deaths and zero serious injuries on Montana’s roadways.

# Multiple Timber Bridges To Be Replaced In Northeastern Montana In 2023

Up To 16 Timber Bridges Constructed In Three Years Through Innovative Design

The Montana Department of Transportation (MDT) and Sletten Construction will replace up to six timber bridges in the Richland, Scobey, and Poplar areas throughout 2023. These bridge replacements are part of a broader Timber Bridges – Glasgow Area project underway to replace up to 16 timber bridges within three years in northeastern Montana.

The six bridges being replaced this year are located on Montana Highway 248 (MT 248), five miles east of Richland, seven miles east of Scobey, and three miles west of Scobey, and Montana Highway 251 (MT 251), 20 miles northeast of Poplar and 25 miles northeast of Poplar. Work will begin as soon as the weather permits.

Depending on the area’s requirements, the bridges will be

replaced by either a concrete culvert or a concrete bridge. For a list of the bridges being replaced and their locations, visit the project webpage: [www.mdt.mt.gov/pubinvolve/glasgowtb/](http://www.mdt.mt.gov/pubinvolve/glasgowtb/).

“MDT is proactively investing in replacing aging timber bridges that are vital to keeping Montanans connected and our economy moving forward,” MDT Glendive District Administrator Shane Mintz said. “Our goal is to replace these structures as quickly as possible, and we have instituted an innovative bridge bundling program to accomplish this.”

Since the project was initiated last fall, Morrison-Maierle, has been working with MDT, alongside Sletten Construction, to bundle projects. This process, known as design-build, readies complex projects efficiently, moving from full design to construction in a matter of months.

“Morrison-Maierle is proud to partner with MDT and Sletten Construction on implementing this program and designing this much-needed infrastructure for local communities,” said Transportation Group Leader for Morrison-Maierle Jim Scoles, Construction detours will be

directly adjacent to the current structures, and minimal traffic disruptions are anticipated. Traffic control will be on site, speed limits reduced, and shoulder closures in place throughout the construction zones. Brief, single-lane road closures may be periodically required.

A motorcycle advisory is in place for all active project sites due to loose asphalt material on the detour structures. Motorcyclists are strongly encouraged to take an alternate route.

“Sletten Construction is eager to work on replacing the first group of bridges,” said Russell Robertson, Bridge Division Manager of Sletten Construction. “We encourage residents to stay informed on bridge replacements underway in their area and reach out with any questions or concerns.”

again the point of pride for Glasgow. At the time the current Scottie Field was filled and then the all weather track was added, it was in the early 1980s and at that time it was considered a premium facility in northern and eastern Montana. Other goals is to address overcrowding at current public facilities and better handle practice overflow, provide a facility for adult, senior citizens and the whole family, while also creating a community atmosphere by providing access 365 days a year. “I hope the whole community looks at this project and Scottie Field as more than just beneficial for Glasgow High School athletics or Glasgow schools and we look at it more of like a community bowl concept,” stressed Flaten.

As explained in the meeting, the project will be broken into three phases, with the first phase being the most important, the track and Scottie Field. This phase will also include new lighting and synthetic field turf. Phase two would be the creation of a softball complex and phase three will be the restroom and ticketing remodel, which as explained during the meeting is the lowest need because there is currently a working facility. However, during the question period at the end of the session, questions were brought up why the bathrooms are not in phase one due to their current conditions. The Scottie Field committee will be discussing the potential to add bathrooms to Phase One at their next meeting on April 27.

“The goal of this effort currently is to go for Phase One and the upcoming bond that would be proposed this fall,” explained Koessler, Information was provided on the current state of the track and football field, including uneven surfaces, which have resulted in many injuries to athletes. “The existing track and field is too old to be salvaged. And the point I like to make is we all want Glasgow to be a place that people want to live, so of course we want this facility to be a place we’re not going to be losing the events that we already have,” said Flaten.

At this point in the project, there is no total determined yet on what the bond would ask for from voters as more information and research needs to be done, including a geotechnical study to pull samples from the current Scottie Field to see exactly what contractors and design would be working with. The first priority is to order the study, with the results being returned by mid-June leaving an additional three weeks to determine final project costs before the Glasgow July School Board meeting. If approved by the School Board, the vote would come up to voters during the General Election on Nov. 7.

In the meantime, the School District has not provided any funds for this project, as the funds have come from private donors and the Scottie Booster Club has agreed to help fund the design as well as will be asked on their May 3 board meeting to cover the cost of the geotech survey. The Scottie Field Recharged Committee will also visit with potential Corporate Sponsors to help lower the taxburden on the community.

on frozen or flooded rivers can be extremely dangerous and is discouraged.

These sites will be closed or restricted until further notice:

Bjornberg Bridge FAS, north of Hwy 2 between Saco and Hinsdale - Closed to all public occupation and recreation as signed.

Alkali Creek FAS, southwest of Malta - Closed to all public occupation and recreation as signed.

Cree Crossing WMA, north

of Sleeping Buffalo - Closed at the lower parking area nearest the river as signed.

Signs informing the public of the closures/restrictions will be posted at access points. Closures or restrictions will be lifted as soon as conditions allow and will depend on the extent and duration of the flooding in the area.

The public is asked to use extreme caution when accessing FWP sites such as fishing access sites, wildlife management areas, state parks, and any other areas near rivers or streams. Flood water elevations change rapidly, and some sites may become partially or fully submerged by flood waters within minutes or hours.

When transporting a spring turkey in the state on Montana, hunters must keep one leg and foot naturally attached for evidence of sex. Montana law requires landowner permission for hunting on all private land.

All Upland Game Bird Enhancement Program enrollments

are currently closed and only open during the fall hunting season. Similarly, most Block Management Areas are also closed, but some open for spring turkey and spring bear opportunities. No shed hunting, hiking or other recreational activities are allowed on these properties without landowner permission. Be sure to check the FWP website for the dates and locations these properties open.
