

We're pleased to report that our drinking water is safe and meets federal and state requirements.

If you want to learn more about our water, please attend any of regularly scheduled meetings. They are held on the first and third Mondays of the month at 5:00 p.m.

Glasgow routinely monitors for constituents in your drinking water according to Federal and State laws. The attached report and this one shows the results of any detects in the monitoring for the period of January 1st to December 31st, 2022. For constituents that are not monitored yearly, we have reviewed our records back to the last time the constituent was monitored.

We have monitored for lead and copper, and all of our samples have been in compliance with the Lead and Copper Rule. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Glasgow is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may contact the city and arrange to have your water tested. The table below provides a summary of results for Lead and Copper samples we collected from the water we supply to you, relative to the action levels for each parameter. 


